Product NUTSHELL Interior & Exterior Varnish Stain is an environmentally friendly wood treatment which

penetrates wood and, when built up, provides a durable, transparent, water-repellent and weatherproof protective layer with excellent elasticity. It is a micro porous treatment with high oil content and contains no petrochemicals or toxic metals. This varnish has been tested and

proved to be resistant to a high degree of air pollution.

Ingredients Boiled linseed oil, wood oil, resin oil, balsam terpinol, clay, silicic acid, plant alcohol, and lead-

free drying agent. The pigments are derived from mineral and other natural substances. These are incorporated in an oil base made from a mixture of plant oils resistant to air pollution and

weather.

Coverage 750 ml of varnish covers approximately 25 sq. metres. Two or three coats are recommended.

Areas of use NUTSHELL Interior & Exterior Varnish Stain is suitable for use on all absorbent surfaces such as

wood, stone, terracotta and cork. It may be used for furniture, doors, windows, panelling, shutters, sills, gates, summer houses etc. The more layers of varnish that are built up, the more

opaque and weatherproof the varnish layer becomes.

Size Available in 0.75 litres and 2.5 litres tins.

Preparation The surface must be sound, clean, dry and grease-free. Less absorbent surfaces must be

thoroughly sanded to give a key. For outdoor use the quality of the finish is improved by first applying one or two coats of NUTSHELL Herb & Resin Oil, followed by two or three coats of

NUTSHELL Interior & Exterior Varnish Stain.

Application Stir thoroughly before use. In order not to diminish the dispersion and penetration, do not apply

below 10°C. The varnish may be applied by brush of spray. Dilute the first coat with 20% NUTSHELL Thinner. Allow to dry thoroughly and follow with two further coats of undiluted varnish. Lightly sand if necessary between coats. The more coats, the more opaque and

weatherproof the varnish becomes.

When applying as a stain or colourwash, brush or rub on one or two thin applications. To avoid the development of a shiny film, brush or wipe over with a lint free cloth ten minutes after

applying.

Drying Time NUTSHELL Interior & Exterior Varnish Stain will be touch dry after 3-4 hours at 18°C; allow 8-12

hours for drying between coats

Thinning & NUTSHELL Interior & Exterior Varnish Stain may be thinned, if necessary, with NUTSHELL Thinner.

Clean tools with NUTSHELL Pure Citrus Peel Oil Thinner immediately after use.
