<b>Product</b>	NUTSHELL Transparent Oil Glaze is an oil based medium used with NUTSHELL Earth & Mineral Pigments for the application of artistic colour washes on walls. Pigments become strong and luminescent when used with this medium. It can be diluted with NUTSHELL Pure Citrus Peel Oil Thinner and is completely micro porous. NUTSHELL Transparent Oil Glazes provides a robust, washable finish on top of NUTSHELL Eco Emulsion.
<b>Ingredients</b>	Boiled linseed oil, wood oil, resin oil, balsam terpinol, clay, silicic acid, plant alcohol, lead-free drying agent.
<b>Coverage</b>	Coverage approximately 750ml per 25 sq. metres.
<b>Areas of use</b>	NUTSHELL Transparent Oil Glaze is suitable for use on all surfaces such as previously emulsioned walls, wood, stone, terracotta and cork. It is suitable for restaurants, hallways, bathrooms and kitchens or wherever a dramatic colourwash is wanted.
<b>Size</b>	Available in 0.75 litre tins.
<b>Preparation</b>	The surface must be sound, clean, dry and grease-free. Walls should be painted first with NUTSHELL Eco Emulsion. Unpainted wood should be given one or two coats of NUTSHELL Herb & Resin Oil; previously painted wood should be lightly sanded to provide a key.
<b>Application</b>	<p>Stir thoroughly before use. The Glaze can be coloured with NUTSHELL Earth and Mineral Pigments. These may be mixed to create an infinite range of shades. To mix, stir the pigment powder with a little thinner or varnish to form a smooth lump-free paste, cover and leave to soak overnight. Grind into a fine paste before adding to the required quantity of varnish and stir thoroughly before use.</p> <p>Application can be made by using a sponge, roller or rag. Colour washes should be applied quickly and systematically. Always let one colour wash dry completely before applying the next layer. Decorative effects are easy to obtain by allowing brush marks to remain or using a roller, rag or sponge to apply a textured wash.</p> <p>NUTSHELL Transparent Oil Glaze has a strong smell of citrus peel oil when it is being applied and rooms must be well ventilated during the application of the product.</p>
<b>Drying Time</b>	NUTSHELL Transparent Oil Glaze will be touch dry after 3-4 hours at 18°C; allow 8-12 hours for drying between coats
<b>Thinning &amp; Cleaning</b>	NUTSHELL Transparent Oil Glaze may be thinned with NUTSHELL Thinner. Clean tools with NUTSHELL Thinner immediately after use.
